RULING

This is an application by way of ex parte notice of motion dated the 22nd day of March 2017 for and on behalf of the Plaintiff/Applicant for the following orders:

1. That leave be granted to the Plaintiff/Applicant herein to issue a Writ of Possession against the Defendant/Respondent in respect of the Defendant/Respondent on the judgment in Default of Defense and all other persons in actual possession (not parties to this proceedings) for all that piece and parcel of land lying and being at Peninsular Circular Road, NO 2 River in the Western Area of the Republic of Sierra Leone.
2. That leave be granted to the Plaintiff/Applicant to issue a Writ of Assistance to aid in the execution of the Writ of Possession to be issued.
3. Any other orders or relief that this honorable court may deem fit and just.
4. That the cost occasioned by this application be borne by the Defendants/Respondents.

I am satisfied that the Defendants/Respondents did not file and or serve defense in this action as required by the High Court Rules 2007.

1.
